## **Solvent Storage Tanks (S33-S36) Hazardous Waste Permit Renewal Requested**

The Department of Energy (DOE)-Savannah River Operations Office has requested from the South Carolina Department of Health and Environmental Control (SCDHEC) a renewal to the Savannah River Site's (SRS) 2000 Resource Conservation and Recovery Act (RCRA) Permit Renewal Application for Volume XXV. This volume of the application contains information about the Solvent Storage Tanks (SSTs) S33-S36. The SSTs are used to store mixed waste solvent and nonhazardous radioactive waste solvent that could have originated from the E-Area Solvent Storage Tanks S-23-S30, F and H Area Separations facilities, or other sources that met the Waste Acceptance Criteria.

The permit renewal application proposes the following changes:

- updating inspection and training requirements (Section H) to reflect current conditions;
- reworking Section I, "Closure Plans, Post-closure Plans, and Financial Requirements," in anticipation of tank closure;
- making editorial changes throughout the document to more accurately reflect current operational conditions, company names, latest revisions of referenced documents, etc.

More information, including the actual permit application, is available for review and copying at the DOE Public Reading Room located in the University of South Carolina-Aiken Library, or by contacting personnel identified in this notice. The Permittee's compliance history during the life of the permit being modified is available from SCDHEC.

Written comments may be sent to SCDHEC. All comments will be considered in the final decision.
